Members Roberts made a motion which no single event can receive funding in this quarter, no more than 25% of total available funds; the Farmer's Market excess amount will be reallocated as original funding to other requests. Member Spears seconded. Mr. Harris stated he approves and stated amount he requested is the exact cost. Chairman Windsor stated allocation of funds is difficult to distribute fairly. After no further discussion, all voted. Motion was approved.
