## NON ACTION ITEMS:

**LODGER'S TAX FINANCIAL REPORT:** City Manager Williams submitted the Lodger's Tax Financial Report to the members for review. Member Roberts discussed the funds available to allocate with keeping \$3000.00 for the dedicated funding for the Chamber and \$4,000.00 as cushion, leaving \$11,500 available for events. Members discussed having a work session to re-evaluate requests and/or adjust category on filling out requests correctly and weighting events, and/or cap on the amount of funding or events proposed; Members are working with a limited number of funds. Chairman Windsor stated Lodger's tax needs to be focused on what event brings in the most people to town to eat, spend money in town, and with a night stay. Member Spears stated estimated funds allocated each quarter is \$11,000. Assistant City Manager Cobb challenged requestors to get information on how many people stay at hotels and stated to consider promoting website to advertise events. Members, Staff and Event Holders discussed various ways to allocate funding and projected funding with impact of oil field and new Comfort Inn.
