CNM Electric, LLC proposes to provide Labor, Materials, and Equipment to add 125-amp 30 space breaker box fed from existing federal pacific panel in equipment room. Feed breaker box with #2 THHN wire. Run conduit and wire to add receptacles for 8 circuits in dance floor area, conduit and wire to computer room to add receptacles for 4 circuits, conduit and wire to conference room to add receptacles for 4 circuits and conduit and wire to classroom to add receptacles for 4 circuits. Build cords that can be plugged into wall and stretched out across floor in dance floor area that will consist of 8 rows each having its own cord with 8 plugs spaced out 8' apart. In classroom, computer room and conference room receptacles on cords will be spaced out 6' apart, each row having its own circuit. Each cord can be stretched out and taped to the floor and rolled back up and put in storage when not in use. Also run 1 Cat-5 Ethernet cord to classroom, conference room, computer room and hallway between youth center and gym and 2 Cat-5 Ethernet cords to dance floor area, all going back to main switch.
