PURPOSE OF MEETING:

Consider approval of zoning change in Extraterritorial Zone from R-1 (Residential) to R-4 (Industrial) for a portion of a tract of land located in Section 35, Township 15 South, Range 35 East, approximately $\frac{1}{2}$ mile West of the intersection of 17^{th} and Gum and $\frac{1}{2}$ mile North of Gum Street.

Consider approval of zoning change in Extraterritorial Zone from R-1 (Residential) to R-4 (Industrial) for a portion of a tract of land located in Section 35, Township 15 South, Range 35 East, approximately ½ mile West of the intersection of 17th and Gum and ½ mile North of Gum Street: City Manager Williams informed members that the owners of a tract of land located 0.5 miles West of Lovington on Gum Street and 0.5 miles North of Gum Street have requested a change in Extraterritorial Zoning class from R-1 (Residential) to R-4 (Industrial). The purpose of this change is to allow for the construction and operation of a solar energy farm. Planning and Zoning Coordinator Ball provided members a copy of a comprehensive plan for land use and informed members that 300 feet of the project property area is in the ETZ property and the rest is County property. Members discussed possible access points to get to land. Member Kitchens asked if adjacent property owners have been advised of Zone Change request. City Manager Williams informed members that the adjacent property owners were notified by letter. Member Wieser made motion to approve the change from R-1 (Residential) to R-4 Industrial.
