Repair of the drainage area and street patching on Avenue J, between 5th Street and 7th Street. Work will include 1,400 SF of asphalt patching and 200 LF of valley gutter.

IV. Provide an explanation for the justification of the procurement including a description of the emergency condition(s) requiring use of emergency procurement and the practicable competition utilized in compliance with NMSA 1978, Section 13-1-127.

Recent rainfall have washed out the drainage area creating large ruts and potholes in the road. These ruts have created dangerous driving conditions as well as increasing

deterioration of the road. The washout has also created a flooding hazard to nearby residences.

V. Please describe what measures are being taken to minimize the duration and effect of this particular emergency procurement (for example: is the emergency only in place until a competitive process can be completed, etc.).

This repair is designed to immediately remedy the safety hazard at the intersection and prevent further deterioration of the road. Reconstruction of this road is needed and will be addressed in the near future. Once planning and design is completed, the project will be let out in a formal competitive process.

VI. Describe what measures the Agency will take in the future to prevent/mitigate use of an emergency procurement under similar circumstances.

A street assessment is being conducted in the new fiscal year as well as a citywide maintenance street maintenance. Preventative maintenance will eliminate the need to such emergency repairs.
